TERMS AND CONDITIONS OF USE

### 1. GENERAL PROVISIONS

#### 2. SUMMARY DESCRIPTION OF THE PROGRAM

### 3. PROGRAM ELIGIBILITY

- 3.1 You are a subscriber of a scholarship plan distributed by KALEIDO. For the purpose of these terms of use, "subscriber" means any customer of Kaleido Growth Inc. who has subscribed to one of the scholarship plans promoted by the Kaleido Foundation and who has at least one account still open.

- 3.3 You comply with the contribution requirements of your scholarship plan.
